COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Internet and Technology has legislative oversight responsibilities for issues concerning State Technology Law, Economic Development Law, Executive Law and General Business Law including but not limited to the internet, technology, computers, email, cybersecurity, forensics, DNA databases and the NYS Broadband Office

During the 2020 Legislative Session, 34 bills were referred to the Committee for its review. Of these bills, three were reported from the Committee. Two were passed by the Senate, and none passed in both houses. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held a Joint virtual roundtable meeting with the Committee on Women's Issue. Topics of this roundtable was the Role of Technology in Domestic Violence.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2020:

S. 4142 sponsored by Senator Savino -

This bill amends the Electronic Signature and Records Act of the State Technology law to define and permit a signature secured through blockchain technology to be accepted as an electronic signature; a record or contract secured through blockchain technology to be accepted as an electronic record; and provides for smart contracts and their enforceability. Additionally the bill defines the following terms:

- "blockchain technology" is defined as a distributed ledger technology that uses a distributed, decentralized, shared and replicated ledger.
- "smart contract" s defined as an event-driven program that runs on a distributed, shared and replicated ledger.

S.6037A by Senator Savino -

This bill would amend the Economic Development Law to add "digital ledger technology" into the definitions of businesses engaged in "financial services data centers or financial services customer back office operations" and "software development" within the Excelsior Jobs Program. For the purposes of this bill "distributed ledger technology" means a mathematically secured, chronological, and decentralized consensus ledger or database, whether maintained via Internet interaction, peer-to-peer network, or otherwise use to authenticate, record, share and synchronize transactions in their respective electronic ledgers or databases.

Additionally, this bill would require, during the application and approval process that the commissioner of the Department of Economic Development strive for broad regional geographic representation within the program. The Commissioner would also be directed to promote diverse ownership and workforces of participating businesses through outreach to businesses owned by people with disabilities, minority- and women-owned businesses and veteran-owned businesses.
