COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Local Government has legislative oversight responsibilities for issues concerning counties, cities, towns, and villages, as well as issues impacting volunteer ambulance workers and firefighters.

During the 2020 Legislative Session, 346 bills were referred to the Committee for its review. Of these bills, 112 were reported from the Committee. 101 were passed by the Senate, and 68 passed in both houses. This work was conducted through a series of six committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.
