Dear Leader Stewart-Cousins,

I am pleased to transmit the Annual Report of the Senate's Standing Committee on Civil Service and Pensions for the 2021 Legislative Session. As Chair, I am proud to continue to lead our efforts to address important matters regarding the public servants and retirement systems of our state.

During the 2021 session, the committee met seven times in session and reported 57 bills, pushing forward key reforms to close loopholes in our state's World Trade Center Presumption Law, provide laborers with adequate leave to receive the COVID-19 vaccine as well as shield them from retaliation due to COVID-related absences, and protect retiree healthcare from proposed cuts in the 2021 Executive Budget. I also conducted an off-session civil service tour in which I visited public servants at their workplaces throughout the state. I learned what it's like to field a 911 call in Suffolk County, mentor and guide a person on parole in New York City, and nurse patients at Helen Hayes, one of the first freestanding public sector rehabilitation hospitals in the country. I also heard from many essential workers who were forced to report to work during the most hazardous months of the pandemic, such as municipal postal workers disseminating information or Office of Mental Health nurses in a psychiatric ward. The stories I heard during the civil service tour cemented what I have always known as Chairman of this committee: despite chronic underinvestment in our public sector workforce, state and local employees have risen to the occasion time and time again, and we must do all that we can as policymakers to support them.

I thank my colleagues who served on the committee for their efforts, and I thank you for the continued support from the Majority Conference in the committee's operations. I am proud of all we have accomplished in the 2021 legislative session, and look forward to a productive New Year.

#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Civil Service and Pensions has legislative oversight of issues concerning the civil service and retirement systems in our state.

During the 2021 legislative session, 227 bills were referred to the committee for its review. Of these bills, 57 were reported from the committee. Forty were passed by the Senate, and 19 passed in both houses. This work was conducted through a series of seven committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

## **COMMITTEE HIGHLIGHTS**

The following key bills were acted on by the committee in 2021:

#### Ch. 401 Sepulveda / Cruz

An act to amend the civil service law, in relation to the promotion and administration of scheduled exams

• Directs the Department of Civil Service to partner with SUNY Educational Opportunity Centers (EOCs) for the hosting of civil service exams

#### Ch. 77 Gounardes / Fall

An act to amend the civil service law and the labor law, in relation to leave time for COVID-19 vaccination; and providing for the repeal of such provisions upon expiration thereof

• Grants all employees across the state four hears of excused leave per injection to receive the coronavirus vaccine

#### Ch. 624 Sepulveda / Reyes

An act to direct the president of the state civil service commission to conduct a study on the current civil service examination process to identify and provide recommendations to improve current methodologies used regarding the examination process to ensure diversity in recruitment and hiring in the public sector

• Directs the Civil Service Commission to conduct a study on how to improve diversity in the recruitment and hiring of candidates who take civil service exams

### Ch. 424 Savino / Abbate

An act to amend the civil service law, in relation to prohibiting public employers from retaliating against employees for absences related to COVID-19

• Prohibits public employers from retaliating against employees who use sick leave or compensatory time to quarantine or seek medical treatment for COVID-10

#### S4233A Gounardes / A6461A Abbate

An act to amend the retirement and social security law and the general municipal law, in relation to disability retirement benefits for the presumption of Parkinson's Disease for paid firefighters

• Establishes a presumption that firefighters who become disabled or die due to Parkinson's Disease incurred such disease as a result of performance of duty

Status: Awaiting action from Governor

### S4859 Skoufis / A6062 Abbate

An act to amend the retirement and social security law, in relation to establishing a twenty-five-year retirement plan for firefighters employed by the division of military and naval affairs

• Creates benefit parity between groups of firefighters who perform similar functions but belong to different pension systems

Status: Awaiting action from Governor

### Ch. 424 Gounardes / Abbate

An act to amend the retirement and social security law, in relation to including certain employees who were employed in public service but became members of a retirement system at a later date for eligibility for those who participated in the World Trade Center rescue, recovery or cleanup operations

• Closes a loophole in the World Trade Center Presumption Law which denied benefits to first responders who participated in rescue, recovery, and cleanup operations but had not joined a pension system at the time of such participation

#### S6276A Mannion / A7223A Epstein

An act to amend the civil service law, in relation to requiring the president of the civil service commission to conduct a study on the employment of persons and veterans with disabilities by the state

• Directs the Civil Service Commission to conduct a study on the public employment of persons and veterans with disabilities and how to better conduct outreach to these populations

Status: Awaiting action from Governor

#### Ch. 541 Mayer / Abbate

An act to amend the education law, in relation to the minimum retirement allowance for members of the New York state teachers' retirement system who retired prior to July 1, 1980

• Increases the minimum retirement allowance for the longest-retired teachers to \$19,250 a year

# TWO HOUSE BILLS

In 2021, 29 of the 227 bills referred to the Standing Committee on Civil Service and Pensions passed both houses of the Legislature. As of this writing, the Governor has signed 19, vetoed one, and has yet to act on nine.
