#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Codes has legislative oversight responsibilities for issues concerning the Penal Law, the Criminal Procedure Law, the Civil Rights Law, and certain parts of the Executive Law.

During the 2021 Legislative Session, over 500 bills were referred to the Standing Committee on Codes for review. Of these bills, approximately 76 were reported from the committee. The breakdown is as follows: 6 were reported and committed to another committee; 34 advanced to third reading; 21 just passed the Senate; and 15 passed both houses and were ultimately signed by the Governor.
