

#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Energy and Telecommunications has legislative oversight responsibilities for issues concerning energy, nuclear power, water companies, public service utilities, communications, and related franchise and tax issues.

During the 2021 Legislative Session, 217 bills were referred to the Committee for its review. Of these bills, 50 were reported from the Committee. Forty-eight were passed by the Senate, and 24 passed in both houses. This work was conducted through a series of seven committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

#### **COMMITTEE HIGHLIGHTS**

#### TWO HOUSE BILLS

In 2021, 24 of the 217 bills referred to the Standing Committee on Energy passed both houses of the Legislature. Of these bills, the Governor has signed 13 and vetoed one. Eight bills are currently being reviewed by the Governor, and two bills await transmission to the Governor.
