COMMITTEE HIGHLIGHTS

The following key bills were acted on or introduced to the Committee in 2021:

The New York Health Act

Establishes the New York Health Plan for state residents (S5474 Rivera - No Movement)

Establishes the New York Health program, a comprehensive system of access to health insurance for New York state residents. Provides for administrative structure of the plan, powers and duties of the board of trustees, the scope of benefits, payment methodologies and care coordination. Further, establishes the New York Health Trust Fund which would hold monies from a variety of sources to be used solely to finance the plan. Enacts provisions related to financing of New York Health, including a payroll assessment, similar to the Medicare tax.

Facility Requirements

Establishes Clinical Staffing Committees (S1168A Rivera - Chapter 155 of 2021)

➤ Requires that every general hospital create a clinical staffing committee made up of registered nurses, licensed practical nurses, ancillary staff members and hospital administrators by January 1, 2022. The committee shall develop and oversee the implementation of a clinical staffing plan. A staffing plan shall include metrics and guidelines for staffing and be based on the number of patients in the hospital's respective units.

❖ Regulation of Compassionate Care-Giving Visitors (S614B May - Chapter 89 of 2021)

➤ Directs the New York State Department of Health (DOH) to develop regulations to allow personal caregiving visitation for, the provision of routine care and support, compassionate caregiving visitation, and the provision of short-term emergency care and support at end of life or other dire circumstances. This care would be provided by individuals designated by the resident and could include family members and legal guardians. This visitation would be for residents of nursing homes and adult care facilities.

Establishes Nursing Home Staffing Levels (S6346 Rivera - Chapter 156 of 2021)

➤ Provides that the Commissioner of the New York State Department of Health (DOH) must establish staffing standards for nursing home minimum staffing levels and impose civil penalties for nursing homes that fail to adhere to minimum standards. Nursing homes will be required to maintain daily staffing hours equal to 3.5 hours of care per resident per day by a nurse aide, licensed practical nurse, or registered nurse.

- Provides Information on Violations Against a Facility (S3185 Skoufis Chapter 344 of 2021)
 - > Requires residential healthcare facilities to provide applicants with ways by which a resident or family can look up complaints taken against the facility.
- Establishes a Direct Care Patient Ratio and Rebate Requirement for Nursing Homes (S4336A Rivera - Passed Senate)
 - ➤ Establishes that nursing homes are required to report revenue and expenditure on staff and maintenance. At least 70percent of all revenue must be spent on residents. The Commissioner of the New York State Department (DOH) of Health shall conduct financial audits when the 70 percent threshold is not met. This concept was included in Part GG of S2507C as part of the state budget.
- Requires Adult Care Facilities to Include Improvement Committees with a Focus on Infection Control in Facilities' Quality Assurance Plans (S1784A Skoufis -Pending)
 - Requires adult care facilities to include performance standards for infection control in their quality assurance plans. Each facility would be required to have a quality improvement committee to meet periodically to review the effectiveness of quality assurance plans and improvement efforts. The committee(s) would include the facility's operator, the resident council or other resident representative, and representatives from frontline employees.
- Establishes an Infection Inspection Audit and Checklist on Nursing Homes (S1783A Skoufis - Pending)
 - ➤ Establishes an annual infection control competency audit for facilities to adhere to which will utilize a checklist of core competencies relating to infection control, personal protective equipment, staffing, clinical care, and communication. If a facility fails to meet a requisite percentage of the criteria, it would be considered not in adherence and additional review would and compliance oversight by the Department of Health would occur.
- Related to the Publication of Nursing Home Ratings (S553 Sanders Chapter 441 of 2021)
 - ➤ Requires that the most recent rating of every nursing home assigned pursuant to the U.S. Centers for Medicare and Medicaid Services (CMS), shall be prominently displayed on the home page of the department's website and at each nursing home facility.

Asthma

- Includes Diagnosis of Asthma or Other Respiratory Diseases in the Statewide Immunization Information System (S1410 Rivera - Passed Senate)
 - Relates to including diagnosis of asthma or other respiratory diseases for which rescue inhaler treatment is prescribed by a health care provider in the statewide immunization information system.
- Enacts the "Lydia Soto Law" (S410A Biaggi Passed Senate)
 - ➤ Enacts the "Lydia Soto law," which establishes a minority coordinating council of asthmatic affairs in New York State. The council shall assess asthma risk factors for minority children in the state, identify barriers for quality asthma treatment and care for minority children, and take steps towards action.
- Relates to Coverage for the Treatment of Asthma (S4934 Rivera Advanced to Third Reading)
 - ➤ Ensures that every health insurance policy includes coverage for the equipment and supplies for the treatment of asthma and for children under 19years of age, as well as additional equipment and supplies for use in school, if recommended or prescribed.
- Directs the New York State Department of Health to Study Asthma in Cities and Towns with Populations of More Than 90,000 (S646A Sanders - Pending)
 - ➤ Requires the New York State Department of Health (DOH) to conduct a study on the incidences of asthma in cities and towns having a population over 90,000 people. The study should be completed by September 30, 2023.
- Establishes a Program of Asthma Disease Management in Control within the New York State Department of Health (S1412 Rivera - Reported to Finance Committee)
 - ➤ Establishes a comprehensive statewide asthma management and control program that coordinates the efforts of individuals, families, health care providers, schools, and community-based organizations to benefit the people of the State of New York.

Addressing Substance Use Disorder

- Enacts the "Overdose Prevention Centers Act" (S2530 Rivera No Movement)
 - Establishes the Overdose Prevention Centers Act, which will allow programs in limited jurisdictions, with either State or City approval, to evaluate and test the public health impact of overdose prevention center services.

Relates to Medication Assisted Treatment for Substance Use Disorders (S649A Harckham - Pending)

- Expands access to buprenorphine products, methadone, or long-acting injectable naltrexone for the treatment of substance use disorders. The bill also prohibits any prior authorization for such medication assisted treatments.
- Directs the New York State Department of Health to Establish an Infant Recovery Centers Pilot Program (S1409 Rivera - Passed Senate)
 - ➤ Requires that the New York State Department of Health in conjunction with the Office of Alcohol and Substance Abuse Services to establish a pilot program of at least four infant recovery centers in areas of need in the state for infants experiencing opioid or other drug withdrawal symptoms.
- ❖ Refers Individuals to Appropriate Service Providers for Substance Use Disorders (S4359A Harckham - Passed Senate)
 - ➤ Requires that addiction service offices provide education materials about substance abuse disorders. Requires that hospitals provide assistance within 72 hours when deemed necessary. Requires hospitals to inform at-risk patients of substance abuse resources.

Women's Health

- Medicaid Coverage Period (S1411A Rivera Passed Senate)
 - ➤ Extends Medicaid coverage for certain pregnant women who access coverage at higher income levels from the current 60-day period after a pregnancy to a year, if federal financial participation is provided, to help reduce maternal mortality and morbidity.
- **❖** Relates to the Accreditation of Midwifery Birth Centers (S1414A Rivera Pending)
 - ➤ Provides that a proposed midwifery birth center that shows the intent and capability to obtain and maintain accreditation by an accrediting body shall be deemed to meet the New York State Department of Health's requirements for initial licensing, contingent on obtaining and maintaining that accreditation.
- Provides a Premium Reduction for Physicians and Midwives who Complete a Risk Management Strategies Course (S3010 Ramos - Passed Senate)
 - Provides continuing education courses that cover risk management strategies in obstetrics for physicians and midwives. Provides premium reduction for completion of these courses.

Lead Poisoning Prevention

Dakota's Law (S5024B Rivera - Passed Senate)

➤ As part of the lead poisoning prevention program, primary health care providers shall provide a parent or guardian of a child under six years of age with anticipatory guidance on lead poisoning prevention as part of routine care, including their right to inspection if the child is an area of high risk. Primary health care providers shall conduct a lead exposure risk assessment questionnaire at each routine well-child visit, or at least annually if a child has not had a routine well-child visit from when they are at six months old until the age of six. Pre-kindergarten institutions shall also be granted access to the statewide immunization information system, the blood lead information in such systems, and the citywide immunization registry.

Potable Water Testing in School Buildings (S2122A Rivera - Pending)

Relates to standards and testing of potable water in school buildings and requires that tap water provided by school districts shall be free to occupants of the school. Removes an exemption of certain schools for testing.

❖ Potable Water Testing at State and Local Parks (S1256A Gianaris - Passed Senate)

Requires potable water testing at state and local parks, at least once every three years. Provides that any finding of lead contamination must be abated within 90days.

Seasonal Products and Decorative Lighting Containing Lead (S5675A Reichlin-Melnick - Chapter 634 of 2021)

➤ Provides that on each seasonal and decorative lighting product manufactured, sold, or delivered by a manufacturer or distributed in the state that contains an electrical cord casing in which lead is present in a quantity greater than one hundred parts per million, there shall be a warning label on such product. There shall be civil penalties imposed on an individual, corporation, or association who violates this act.

S1016B Gaughran

Establishes the Dominic Murray Sudden Cardiac Arrest Prevention Act. This Act directs the commissioners of the Department of Education (DOE) and Department of Health (DOH) to establish rules and regulations for the treatment and monitoring of students in school districts, boards of cooperative educational services, and nonpublic schools who exhibit signs or symptoms of sudden cardiac arrest.

S1168A Rivera

Requires that every general hospital create a clinical staffing committee made up of registered nurses, licensed practical nurses, ancillary staff members and hospital administrators by January 1, 2022. The committee shall develop and oversee the implementation of a clinical staffing plan. A staffing plan shall include metrics and guidelines for staffing and be based on the number of patients in the hospital's respective units.

Chapter 155 of 2021

S1201A Harckham

Requires the Department of Health (DOH) to maintain a schedule of when they will offer competency exams to qualified home care service workers residing outside of the state to fill any shortage of home care services working in the state.

S1451A Rivera

Includes consideration in the Certificate of Need Process of a project's impact on medically underserved groups in New York State to the documentation required for an applicant to submit to the review to consider when reviewing their application.

S1759A Skoufis

Directs the commissioner of the New York State Pending. Department of Health to promulgate the first list of emerging contaminants within 30 days of enactment. Thereafter, the commissioner shall add new emerging contaminants to the list at least once every three years.

S1783A Skoufis

Establishes an annual infection control competency audit for facilities to adhere to which will utilize a checklist of core competencies relating to infection control, personal protective equipment, staffing, clinical care, and communication. If a facility fails to meet 60% of the criteria, it will be considered not in adherence and monthly audits will commence until a facility meets at least 85% adherence with the criteria.
