I am pleased to transmit the Annual Report of the Senate's Standing Committee on Mental Health for the 2021 Legislative Session. As Chair, I am proud to continue to lead our efforts to address important matters under my committee's jurisdiction. I would like to convey my sincere appreciation for the privilege of being appointed Chairperson of the Mental Health Committee.

As you know, the issue area of mental health can be both challenging and rewarding. During the year, I conducted meetings with many advocates expressing appreciation for what the Senate Majority has done to further the discussion of quality care for those who are members of this vulnerable population. The COVID-19 pandemic has presented unique challenges to those facing mental health struggles, as well as highlighted the increased need for mental health services in what has been a very isolating time period for many. I have been a champion for the non-profit agencies who have seen their budgets stagnate, and I have fought for increased wages and investment into a workforce that is facing many struggles. It has become even more apparent during the pandemic that those working in the mental health field need to be properly compensated and equipped. We must continue our work on workforce recruitment and retention to ensure we can provide the services needed by communities across the State.

During the 2021 session, the Mental Health Committee met three times in session and reported eighteen bills. The Committee also held one hearing on Mental Health Crisis Services this past year.

COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Mental Health has legislative oversight responsibilities for issues concerning the mental health needs of New Yorkers.

During the 2021 Legislative Session, **68** bills were referred to the Committee for its review. Of these bills, **18** were reported from the Committee. **12** were passed by the Senate, and **4** passed in both houses. This work was conducted through a series of **3** committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held 1 hearings and/or roundtable meetings. Topics of these hearings and/or roundtables included Mental Health Crisis Services.

COMMITTEE HIGHLIGHTS & HEARINGS

The following key bills were acted on by the committee in 2021:

- **S2209** (**Sepúlveda**): Relates to annual reporting on substance use disorder in incarcerated individuals.
 - Chapter 494 of the Laws of 2021 requires the Office of Addiction Services and Supports to update its guidelines for correctional substance use disorder treatment, in line with best practices, and requires annual reporting of data on the substances that incarcerated individuals are most commonly addicted to and what treatment they receive.
- **S6194B (Brouk):** Relates to establishing a 9-8-8 suicide prevention and mental health crisis hotline system.
 - Chapter 793 of 2021 establishes a three-digit, 9-8-8, suicide prevention and mental health crisis hotline system by July 16, 2022.
- **S5938 (Parker):** Establishes a peer support services program for transgender and non-binary individuals.
 - This bill passed the Senate only. The legislation would establish a peer support program for transgender and non-binary individuals, and develop and establish regional and county-based support services for such individuals. These services include but are not limited to peer counseling for mental illness including alcohol and substance abuse counseling, family support services, domestic violence, mental health and physical health.
