COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Transportation has legislative oversight responsibilities for issues concerning canals, highways, navigation, transportation authorities, railroads, rapid transit, aviation, and vehicle and traffic laws.

During the 2021 Legislative Session, 492 bills were referred to the Committee for its review. Of these bills, 131 were reported from the Committee. 117 were passed by the Senate, and 55 passed in both houses. This work was conducted through a series of eight committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held three hearings and/or roundtable meetings. Topics of these hearings and/or roundtables included MTA East Side Access/East River Tunnels, debt of taxi drivers, and an overall update of MTA finances.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2021:

- S.524A (Hoylman) Passed Senate. This bill, named in tribute of Sammy Cohen Eckstein, a 12 year old boy who was truck and killed by a vehicle in 2013, would allow New York City to reduce its speed limit to 20mph. Studies have shown that survival rates for pedestrians struck at speeds of 20mph or lower is much higher than at a speed of 25mph.
- S.6202 (Kennedy) Passed Senate. This bill would add additional violations and crimes, with regard to reckless driving. Current laws do not cover every action, and often times DAs fail to bring charges, citing the lack of laws allowing them to do so. In response, this bill gives more tools to DA's to crack down on reckless driving.
- S.2740 (Kavanagh) Awaiting action by Governor. This bill would establish a
 demonstration program, allowing for electronic weigh-in-motion technology to be used
 on the BQE in NYC. This comes in response to a 2019 report by NYC that had findings
 that included illegal overweight vehicles are contributing significantly to the structure's
 decline. If implemented, this will be the first type of such program in existence in all of
 New York State.
- S.4625A (Comrie) Chapter 482. This bill enacts the MTA open data act. A frustration
 for lawmakers and the public alike has been either the lack of data released, or data
 released in formats difficult to access by the public, usually in PDF format. To rectify this,
 the bill requires data be published in open data formats, which are easily accessed,
 downloaded and manipulated by the public.
- S.4682B (Kennedy) Chapter 421. This bill establishes a first in the state demonstration program implementing speed violation monitoring systems in work zones by means of electronic devices. Such programs will address injuries and fatalities by highway workers, where speed is often a factor. Between 2010-2016, there were 3,450 accidents in workzones on state highways, and for every increase of 6mph, the likelihood of an accident with injuries increases by 20%. Similar programs in other states has been successful: Maryland saw a 10% reduction in driver speeds, 59% reduction in motorists traveling more than 10mph over the speed limit, and a 45% reduction in the number of fatalities from workzone related accidents.
- S.5486A (Kennedy) Chapter 618. This bill establishes a CDL class A young adult program. This change will help address the industry wide driver shortage, where across the nation in 2017, there was a 50,000 driver shortage. By enacting this law, New York became the final state to allow individuals under the age of 21 to obtain a class A CDL license.

TWO HOUSE BILLS

In 2021, 55 of the 491 bills referred to the Standing Committee on Transportation passed both houses of the Legislature. Of these bills, the Governor has signed 47 and vetoed 1.
