COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Civil Service and Pensions has legislative oversight responsibilities for issues concerning the civil service and retirement systems in our state.

During the 2022 Legislative Session, 256 bills were referred to the Committee for its review. Of these bills, 39 were reported from the Committee. Twenty-One were passed by both houses and seven were passed by the Senate only. The Governor has signed 8 bills into law and vetoed 4 bills. Eight bills are awaiting action by the Governor and 1 bill was delivered to the Governor. This work was conducted through a series of four committee meetings. Additionally, one meeting was held on the nomination of Timothy Hogues to be a member, designated as chair, of the Civil Service Commission. A list of all bills that were reported from the committee is provided at the end of this report.
