COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Codes has legislative oversight responsibilities for issues concerning the Penal Law, the Criminal Procedure Law, the Civil Rights Law, and certain parts of the Executive Law.

During the 2022 Legislative Session, over 500 bills were referred to the committee for review. Of these bills, 75 were placed on agendas and 74 were reported from committee (one bill was defeated). Of this subset, 30 bills passed the Senate. Five of these 30 bills also passed the Assembly. This work was conducted through a series of eight committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

The committee did not hold any specific public hearings or roundtable meetings during this session, but as Chair I did participate in the joint legislative public hearings concerning the annual budget.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2022:

- **S1553D Myrie -** Relates to the automatic sealing of certain convictions Passed Senate; delivered to Assembly
- S6363A Mayer Requires the court to order the search for and immediate seizure of certain firearms when a defendant willfully refuses to surrender such firearms- Signed chapter 576 of 2022
- S6443B Mayer Relates to orders of protection- Signed chapter 577 of 2022

TWO HOUSE BILLS

In 2022, five of the more than 500 bills that were referred to the Standing Committee on Codes passed both houses of the Legislature. Of these bills, the Governor has signed four and vetoed one.
