

COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Crime Victims, Crime and Correction has legislative oversight responsibilities for issues concerning the criminal justice system, its oversight, and the people it serves.

During the 2022 Legislative Session, one hundred ninety-four bills were referred to the Committee for its review. Of these bills, twenty-seven were reported from the Committee. Twelve were passed by the Senate, and seven passed in both houses. This work was conducted through a series of six committee meetings. A list of all bills that were reported from the Committee is provided at the end of this report.

In addition to its regular meetings, the Committee held two public hearings Topics of these hearings included:

- Sexual Assault in Prisons
- Parole Justice

COMMITTEE HIGHLIGHTS

The most significant work of the Standing Committee on Crime Victims, Crime and Correction related to the ongoing work to monitor the implementation of HALT Solitary Confinement Act of 2021, enacted as Chapter 93 of 2021, and The Less is More Bill, enacted as Chapter 427 pf 2021. The work of the Chair included multiple visits to Correctional Facilities including but not limited to, Upstate Correctional, Midstate Correctional, Green Haven Correctional, and the jails on Riker's Island.

The Committee Chair is deeply committed to addressing the ongoing and pervasive issues related to incarceration. In order to solicit public and community voices, two public hearings were held. Senator Salazar and Senator Biaggi held a hearing to gain insight on the issue of sexual assaults in NYS prisons, and Senator Salazar and Senator Hoylman held a hearing on Parole Justice, specifically S7514 (Fair & Timely Parole) and S15A (Elder Parole).

Additionally, S8975 and S8976, sponsored by Senator Salazar, were enacted as Chapters 239 and 343 to expand award eligibility for crime victims.

TWO HOUSE BILLS

In 2022, eight of the one hundred ninety-four bills referred to the Standing Committee on Crime Victims, Crime and Correction passed both houses of the Legislature. Of these bills, the Governor has signed six and vetoed two.
