COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Finance has legislative oversight responsibilities for issues concerning Budget, Fiscal Review, Resolutions and Nominations.

During the 2022 Legislative Session, 685 bills were referred or dual referenced to the Committee for its review. Of these bills, 179 were reported from the Committee. 201 were passed by the Senate, and 112 passed in both houses. This work was conducted through a series of 19 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held 13 hearings and/or roundtable meetings. Topics of these hearings and/or roundtables included

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2022:

- S1046E Myrie Relates to the John R. Lewis Voting Rights Act of New York; establishes rights of actions for denying or abridging the right of any member of a protected class to vote; provides assistance to language-minority groups; provides for preclearance of certain voting policies; makes related provisions.
