

#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Health has legislative oversight responsibilities for a broad range of issues including the general operation of healthcare facilities and the delivery of healthcare services to those within our state. This year the committee advanced a number of measures to address important issues including lead poisoning prevention, funding for distressed hospitals, Medicaid eligibility and services, organ donation, pharmaceutical pricing, and many others.

During the 2022 Legislative Session, 562 bills were referred to the Committee for its review. Of these bills, 138 were reported from the Committee. 87 were passed by the Senate, and 56 passed in both houses. This work was conducted through a series of 9 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held one hearing on the proposed SFY 2022-23 budget.

# **COMMITTEE HIGHLIGHTS**

The following key bills were acted on by the committee in 2022:

#### The New York Health Act

#### • Establishes the New York Health Act (S5474 Rivera - No Movement)

 Establishes the New York Health program, a comprehensive system of access to health insurance for New York state residents; provides for the administrative structure of the plan; provides for powers and duties of the board of trustees, the scope of benefits, payment methodologies and care coordination; establishes the New York Health Trust Fund which would hold monies from a variety of sources to be used solely to finance the plan; enacts provisions relating to the financing of New York Health, including a payroll assessment, similar to the Medicare tax; establishes a temporary commission on implementation of the plan; provides for collective negotiations by health care providers with New York Health.

#### **Essential Plan**

- Expands Eligibility for the Essential Plan (S1572 Rivera Committed to Finance)
  - Provides eligibility for services under the basic health program for individuals whose immigration status renders him or her ineligible for federal financial participation and who meet additional requirements.

#### **Medicaid Services**

- Provides Automatic Enrollment and Recertification for Medicaid Eligible Recipients (S4965 Rivera - Passed Senate)
  - Provides for automatic enrollment and recertification simplification for Medicaid managed care plans and long-term care plans.
- Repeals Limitations on Eligibility for Person Care Services (S5028A Rivera - No Movement)
  - Eliminates the requirement that applicants for personal care services need assistance with multiple activities of daily living in order to qualify. This language was included in the Senate one-house budget proposal.
- Synchronization of Prescription Medications (S431A Hoylman Passed both Houses)
  - Authorizes pharmacists to synchronize the dispensing of multiple prescriptions for Medicaid recipients to improve medication adherence and facilitate enrollee access.

- Expanding Eligibility for Long Term Home Care (S2542A Rivera Passed Senate)
  - Modifies the "look-back period" for the determination of eligibility of an individual for medical assistance benefits to exempt certain assets used on the individual's behalf or for care services provided to the individual by a family member or informal caregiver.
- Services for Individuals with Traumatic Brain Injuries and Nursing Home Diversion Waivers (S1577A Rivera - Passed Senate)
  - Provides that services to medical assistance recipients suffering from traumatic brain injuries or qualifying for nursing home diversion and transition services shall be provided outside of managed programs.

# **Medical Debt**

- Prohibiting Surprise Facility Fee Billing (S2521C Rivera Passed Senate)
  - Requires notice to patients prior to a hospital or professional practice charging a patient for a facility fee, including whether the patient's health coverage will cover the fee.

#### Telehealth

- Enacts Specific Provisions Regarding the Delivery of Health Care Services via TeleHealth (S5505 Rivera Committed to Finance)
  - Enacts specific provisions regarding the delivery of health care services via telehealth including establishing payment parity between the delivery of health care services via telehealth and services delivered in a traditional in-person environment and to provide for patient protections.

#### **Lead Poisoning Prevention**

- Dakota's Law (S5024D Rivera Chapter 532 of 2022)
  - Promotes lead poisoning prevention by enhancing standards for assessments and establishing requirements related to testing and screening.
- Potable Water Testing at State and Local Parks (S1256A Gianaris Passed Senate)
  - Establishes standards for the testing of potable water in state and local parks and makes the results of such testing publicly accessible.

# Asthma

- Authorizing the Possession and Use of Rescue Inhalers (S4935 Rivera Pass Both Houses)
  - Authorizes access to rescue inhaler treatment devices for emergency situations and establishes liability protections for their use to assist someone in need.
- Enacts the "Lydia Soto Law" (S410A Biaggi Vetoed Memo 69)
  - Establishes a Minority Coordinating Council on Asthmatic Affairs within the Department of Health to assess the asthma risk factors for the minority citizens of our state, counties, and regions.
- Relates to Coverage for the Treatment of Asthma (S4934 Rivera -Committed to Rules)
  - Ensures that every health insurance policy includes coverage for the equipment and supplies for the treatment of asthma and for children under 19 years of age, as well as additional equipment and supplies for use in school, if recommended or prescribed.

#### Addressing Substance Use Disorder

- Enacts The Safer Consumption Services Act (S603 Rivera No Movement)
  Authorizes the state and localities to establish overdose prevention centers to support individuals with substance use disorder by providing education, bridges to addiction treatment and social welfare services, and emergency medical treatment if needed.
- Maternal-infant Care Centers (S1409B Rivera Committed to Rules)
  - Requires that the New York State Department of Health in conjunction with the Office of Alcohol and Substance Abuse Services to establish a pilot program of at least four maternal-infant care centers in areas of need in the state.

#### Women's Health

- Medicaid Coverage Period (S1411A Rivera Committed to Rules)
  - Extends Medicaid coverage for certain pregnant women who access coverage at higher income levels from the current 60-day period after pregnancy to a year, if federal financial participation is provided, to help reduce maternal mortality and morbidity. The provisions of this legislation were included in the enacted the SFY 2022-23 budget.
- Risk Management Strategies (S3010 Ramos Passed Both Houses)

 Provides continuing education courses that cover risk management strategies in obstetrics for physicians and midwives. Provides premium reduction for completion of these courses.

# **Medically Fragile Children**

- Health Services for Medically Fragile Children (S2121C Rivera Passed Both Houses)
  - Relates to enhancing coverage and care for medically fragile children; requires that health plans adopt policies and procedures tailored to the unique healthcare needs of this population.

# **Organ Donation**

- Living Donor Support Act (S1594 Rivera Passed Both Houses)
  - Enacts the "New York state living donor support act" to provide state reimbursement to living organ donors, who are state residents, for medical and associated expenses incurred as result of the organ donation, when the organ donation is made to another resident of the state; requires the provision of information on transplantation to patients with severe kidney disease.
