#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Local Government has legislative oversight responsibilities for issues concerning counties, cities, towns, and villages, as well as issues affecting volunteer ambulance workers and firefighters.

During the 2022 Legislative Session, 379 bills were referred to the Committee for its review. Of these bills, 74 were reported from the Committee. 64 were passed by the Senate, and 30 passed in both houses. This work was conducted through a series of 6 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

#### **COMMITTEE HIGHLIGHTS**

The following key bills were acted on by the committee in 2022:

- S3256/Comrie: On the Governor's Desk. This bill requires that prior to final approval, an IDA must provide notice and confirm delivery of such notice, of any projects proposed for development or deviation to affected local taxing jurisdictions and school districts. This promotes transparency and coordination amongst stakeholders without inhibiting economic growth or adversely affecting school district revenues or local taxpayers.
- S3527B/Bailey: Reported from Committee. The last raise for 18-b assigned counsel attorneys, who provide legal representation to children and indigent persons, was in 2004 to \$75/hour. This is far below the average rate of compensation for attorneys in NYS. This legislation raises the rate to \$150/hour in an effort to maintain the quality of attorneys available and attract experienced and qualified attorneys.
- S4471A/Mannion: On the Governor's Desk. This bill requires IDAs notify local taxing jurisdictions within two years of the expiration of a PILOT, or immediately in the event of an early termination. This coupled, with S3256, increases communication and transparency, while allowing for taxing jurisdictions to adequately plan budgets.
- S7186A/Brooks: Passed Senate. Also known as the "EMS Cost Recovery Act,"
  this bill allows volunteer fire department to recover costs for emergency medical
  services rendered. This bill was included in the Enacted 2022-23 New York State
  Budget and now joins the nation in allowing cost recovery for volunteer fire
  department EMS services while providing over \$100 million in local property tax
  relief across the state.
- S7399A/Gaughran: Chapter 654 of 2022. In 2021, a law was enacted that
  allowed local governments the ability to provide additional Length of Service
  Award Program (LOSAP) credits to volunteer firefighters who are still actively
  participating after 40 years of service, the maximum time frame. This bill
  provides parity by including volunteer ambulance workers.
- S8338/Gaughran: Chapter 196 of 2022. Currently, political subdivisions can donate surplus computer equipment to local schools, libraries and other not-for-profit organizations through SED's C.R.E.A.T.E. Programs. The law was set to expire in July 2022, and this law extends the expiration to July 2025.
- S8561A/Skoufis: On the Governor's Desk. In an effort to prevent confusion over whether a county website is credible or a falsified website, this legislation requires all counties maintain a .gov domain.
- S8717/Gaughran: Chapter 455 of 2022. Extends the ability of municipalities, school districts and other local governmental entities to use cooperative purchasing contracts (also known as "piggy-backing") to achieve cost savings through greater contract flexibility and procurement efficiencies, by amending the sunset of General Municipal Law § 103(16) from 2023 to 2026.

#### TWO HOUSE BILLS

In 2022, 30 of the 379 bills referred to the Standing Committee on Local Government passed both houses of the Legislature. Of these bills, the Governor has signed 21 and vetoed 1 and is pending action on 8.
