

COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Procurement and Contracts has legislative oversight responsibilities for issues concerning procurement and contracting actions including competitive bidding, procurement lobbying, preferred source, as well as minority and women-owned business enterprises.

During the 2022 Legislative Session, seventy-three (73) bills were referred to the Committee for its review. Of these bills, twenty-nine (29) were reported directly from the Committee and three (3) were discharged to the Committee on Rules. Nineteen (19) were passed by the Senate, and six (6) passed in both houses. This work was conducted through a series of four (4) committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2022:

- S. 7578C By Senator Mannion to modernize the preferred source program with regard to New Yorkers with Intellectual and Developmental Disabilities
- S. 8446A By Senator Reichlin-Melnick to enact the "Stop Russian Aggression Act" which would prohibit the state of New York from contracting with any company doing business with or in Russia.
- S. 8844 By Senator Reichlin-Melnick to address materials cost escalation by providing relief to contractors and subcontractors contracting with New York State who have been significantly impacted by such materials costs.
- S. 9441 By Senator Kennedy to require New York State agencies and authorities to purchase rock salt harvested from American mines.

Bills with a focus on promoting government transparency and equity in contracting:

- S. 2239 By Senator Hoylman to require state contractors to disclose data on employee compensation by gender, race, ethnicity.
- S. 3736 By Senator Comrie to require state agencies to provide prompt written notice to unsuccessful MWBE bidders as to why they were not selected for a bid as well as disclose the successful bidder.
- S. 6626A By Senator Krueger to increase the transparency and flexibility of the state's procurement process.
- S. 8062 By Senator Reichlin-Melnick to ensure the New York State Comptroller's authority to review contracts prior to ratification remains intact during a state of emergency that lasts beyond 30-days.
- S. 8086 By Senator Reichlin-Melnick to require the Office of the State Comptroller to conduct a study on all contracts entered into by the Executive or any state agency during the Covid-19 State of Emergency.

Bills with a focus on environmental sustainability and green contracting:

- S. 370A By Senator Hoylman to require all state-owned and operated parking garages and lots that accommodate between 50 and 200 parking spaces to install electric vehicle charging stations.
- S. 5921A By Senator Krueger to enact the New York deforestation-free procurement act to ensure that companies contracting with New York State are not contributing to tropical or boreal intact forest degradation or deforestation directly or through their supply chains.
- S. 8221 By Senator Breslin to require that New York State facilities at the Empire State Plaza complex in Albany shall entirely use renewables for power, heat and cooling.

TWO HOUSE BILLS

In 2022, six of the seventy-three (73) bills referred to the Standing Committee on Procurement and Contracts passed both houses of the Legislature. Of these bills, the Governor has signed four (4), vetoed one (1) and one (1) bill is on the governor's desk awaiting action.
