

#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Social Services has legislative oversight responsibilities for issues concerning the alleviation of poverty, assistance to survivors of domestic violence, services for disconnected youth, assistance for individuals with disabilities, workforce readiness and a vast network of human services programs reaching vulnerable New Yorkers.

During the 2023 Legislative Session, 65 bills were referred to the Committee for its review. Of these bills, 18 were reported from the Committee. 12 were passed by the Senate, and eight passed in both houses. This work was conducted through a series of four committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held a joint hearing with the Women's Issues Committee regarding services and programs for survivors of gender-based and domestic violence.

#### **COMMITTEE HIGHLIGHTS**

The following key bills were acted on by the committee in 2023:

- S2144 (Persaud) would provide public assistance recipients that have completed a public assistance employment program, and are transitioning off of assistance, with a six month 100% earned income disregard allowing for retention of certain existing benefits for six months. This bill passed the Senate only.
- S2982 (Kavanagh) would require all local social services districts to issue shelter allowances equal to 100% of the applicable HUD Fair Market Rent. This bill was reported from the Committee.
- S6424B (Persaud) would add the NYS Thruway Authority and NYS Departments of Motor Vehicles and Transportation, respectively, to the Interagency Taskforce on Human Trafficking. This bill passed in the Senate only. S7451, now Chapter 496 of 2023, added only the Secretary of State.
- S7259A (Persaud) would establish a Fiscal Cliff Taskforce to study public benefits "cliffs" in SNAP, subsidized childcare, Medicaid, and other programs that assist low-income New Yorkers. S7259A received a veto message.

## **TWO HOUSE BILLS**

In 2023, eight of the 65 bills referred to the Standing Committee on Social Services passed both houses of the Legislature. The Governor has signed six bills and vetoed two.
