Dear Senator Stewart-Cousins:

I am pleased to transmit the Annual Report of the Senate's Standing Committee on Aging for the 2022 Legislative Session. As Chair, I am proud to continue to lead our efforts to address important matters under my committee's jurisdiction like the state's longterm care ombudsman program (LTCOP), elder care services and prevention of fraud and other abuses, and the safety and care of our nursing home residents. During the 2022 session, the Aging committee met 3 times during session and reported 14 bills.

Our work as Chairs of Committees often extends beyond the room where we consider legislation. This year, during the budget cycle, at budget hearings and through my own legislation, I spoke often and strongly about the great need to support those who care for our most vulnerable residents, our seniors. I fought hard for a meaningful and fair increase in the caregivers' hourly wage, and the campaign to accomplish this took on a life of its own for the entire session. With your support and leadership we secured the largest investment in home care wages any state has ever made. We are now continuing to push for the successful rollout of this wage increase, and I will always support the vital work our caregivers in this state do for our older New Yorkers. The Fair Pay movement brought many Senators, advocates, and workers together around a common and vitally important challenge and I will always consider this heartfelt and hardfought victory one of my proudest achievements as Chair of the Aging Committee.

I thank my colleagues who served on the Committee for their efforts and support of the work that was done in the committee this year, and I thank you for the continued support from the Majority Conference in the committee's operations.

#### **COMMITTEE JURISDICTION AND OVERVIEW**

The New York State Senate Standing Committee on Aging has legislative oversight responsibilities for issues concerning Elder Law, nursing homes, caregivers, and senior services.

During the 2022 Legislative Session, 72 bills were referred to the Committee for its review. Of these bills, 14 were reported from the Committee. Including several bills discharged from the Committee to the Rules Committee after regular committee meetings ended, 15 were passed by the Senate, and 11 passed in both houses. This work was conducted through a series of 3 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

#### **COMMITTEE HIGHLIGHTS**

The following key bills were acted on by the committee in 2022:

- S72 (Hoylman) Clarifying the meaning of the phrase "greatest social need" for purposes of the administration of programs under the federal Older Americans Act of 1965
- S8617A (May) relating to the annual reporting requirements of the state longterm care ombudsman program
- S3085A (Stewart-Cousins) Increases the amount of income property owners
  may earn for the purpose of eligibility for the property tax exemption for persons
  over sixty-five years of age and persons with disabilities and limited income
- S3483 (Bailey) Relates to income eligibility under the EPIC program

## **TWO HOUSE BILLS**

In 2022, Fifteen of the 72 bills referred to the Standing Committee on Aging passed both houses of the Legislature. Of these bills, the Governor has signed 5 and vetoed 1.
