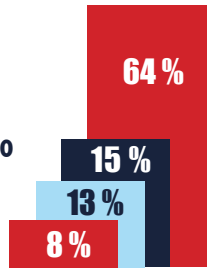

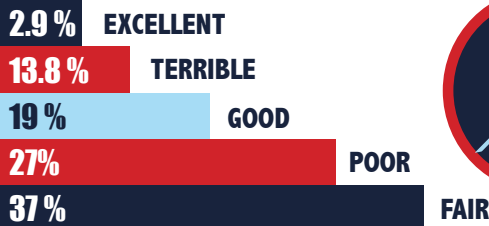

DO YOU SUPPORT OR OPPOSE CONTINUING TO DEFER RENT AND EVICTIONS?



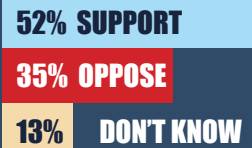
HOW WOULD YOU RATE NEW YORK'S VACCINE DISTRIBUTION?



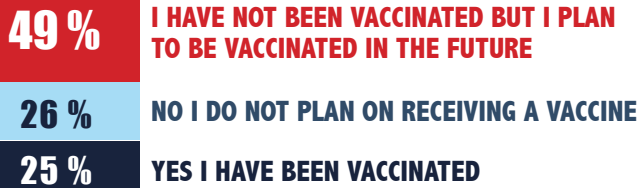

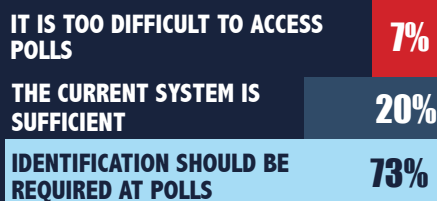
HAVE YOU RECEIVED A COVID-19 VACCINE OR DO YOU PLAN TO RECEIVE ONE WHEN AVAILABLE?



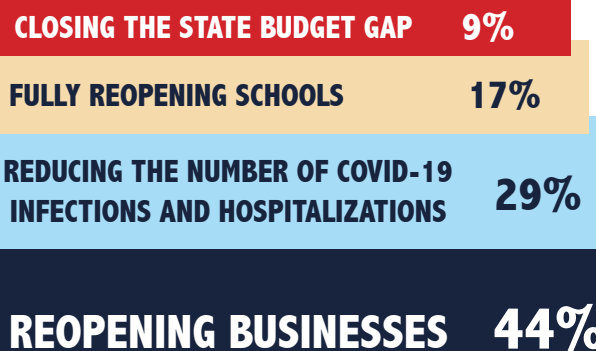
