Dear Ms. Nathanson,

It has come to our attention that Dotdash Meredith appears to be failing to comply with sections 218-b and 27-d of the New York State Labor Law, also referred to as the "NY HERO Act." We write to express our support for the nearly 200 employees of Dotdash Meredith Union, part of the NewsGuild of New York, CWA Local 31003, and their fight for health and safety standards in their workplace consistent with the HERO Act.

The legislature passed the HERO Act in 2021 to protect employees from the threat of COVID-19 and future airborne diseases in the workplace. The law mandates enforceable minimum health and safety standards, including the provision of PPE, requirements for social distancing and personal hygiene, and engineering controls. The law was also written with the recognition that workers themselves are often in the best position to monitor the safety of their workplaces, and therefore it requires employers to recognize employee-led health and safety committees to help safeguard against exposure to airborne infectious diseases. Governor Kathy Hochul designated COVID-19 an airborne infectious disease in September 2021—and has maintained that designation since—because of the ongoing hazard the virus continues to pose.

After speaking with your workers, it appears that Dotdash Meredith is not adhering to the requirements of the HERO Act. According to several Meredith Union members, the company has failed to comply with its own airborne infectious disease exposure plan and does not recognize their ability to form a workplace safety committee. As the designated management employee responsible for HERO Act compliance and communication, Meredith Union workers also contend these compliance failures were brought to your attention but that they did not receive a response.

The workers at Meredith, like many workers in New York State, are empowered by law to form health and safety committees to monitor their employer's compliance with their airborne infectious disease exposure plan and request enforcement in areas where management has failed.

Dotdash Meredith employees have always worked tirelessly to produce popular, highquality products—even more so during the past two tumultuous years. Their labor continues to deliver rewards to the company and its shareholders—Dotdash purchased Meredith for \$2.7 billion last fall. Their health is the health of the company. Therefore, we write to ask that you and Dotdash Meredith review the provisions set forth by the Department of Labor in relation to Labor Law sections 218-b and 27-d and ensure immediate compliance with the required health and safety standards. We expect a prompt reply to these concerns.
