To the Chairs and Members of the Joint Fiscal Committees:

The Long Island Association respectfully requests that this year's state budget includes the project to modernize Belmont Park in Nassau County. This project would spur economic growth both on Long Island and throughout the state, boost the surrounding area businesses, and secure the future of horse racing in New York.

Your support for this initiative is crucial. The \$455 million project to modernize Belmont Park, which was built more than a century ago in 1905 and last upgraded in 1968, requires authorization from Albany for state-backed bonds — but it would be funded entirely by the New York Racing Association, Inc. (NYRA), and would not use any taxpayer funds.

This transformational project could generate approximately \$1 billion in constructionrelated economic impact and 3,700 construction jobs. Once complete, the new Belmont Park could create a recurring \$155 million in annual economic impact and sustain 740 new full-time jobs.

Horse racing in New York State generates approximately \$3 billion in annual economic activity and sustains 19,000 jobs for New Yorkers — buoying the economy on Long Island and the entire state. Modernizing Belmont would ensure this sport has a future in New York, supporting thousands of families and small businesses.



On Long Island alone, a stronger future for horse racing would mean small businesses would continue to benefit from sport's economic impact — such as the \$10 million in economic activity the Belmont Stakes brings to the county and local communities each year. What's more, other major events like the Breeders' Cup World Championship — thoroughbred horse racing's year-end major event — have committed to return to New York State if Belmont Park is updated. The Breeders' Cup, which has not been hosted here since 2005 due to the poor conditions at Belmont, is estimated to generate a nearly \$100 million economic impact when it returns.

For these reasons, we urge you to include the modernization of Belmont Park in the state budget. Thank you for your consideration.

Your support for this initiative is crucial. The \$455 million project to modernize Belmont Park, which was built over a century ago in 1905 and last upgraded in 1968, requires authorization from Albany for state-backed bonds — but it would be funded entirely by the New York Racing Association, Inc. (NYRA), and would not use any taxpayer funds.

The construction project — one of the largest in generations — would generate \$1 billion in construction-related economic impact and 3,700 construction jobs. Once complete, the new Belmont Park would create a recurring \$155 million in annual economic impact and sustain 740 new full time jobs.

These numbers show Belmont Park's major economic impact — but they only tell half of the story.

Horse racing in New York State generates \$3 billion in annual economic activity and sustains 19,000 jobs for New Yorkers — buoying the economy in the Capitol Region, on Long Island, and across the Empire State. Modernizing Belmont would ensure this sport has a future in New York, supporting thousands of families and small businesses like ours.

In Saratoga alone, the Race Course attracts over 1 million attendees per year, generating \$240 million in annual revenue for the Capitol Region. In Saratoga, the revenue per available room — a key measure of our hospitality sector's health — rose 128 percent between 2020, when there was no in-person racing, and 2021 when the Saratoga Race Course was once again open to the public. And our county's sales tax revenue increased nearly 26% last year, in large part due to the tourism boost from horse racing.

Modernizing Belmont Park enjoys supermajority support (68%) across the state because New Yorkers understand the positive impact horse racing has on the Empire State, on our economy, and on small businesses.

As small business owners and supporters, we ask you to listen to your constituents and support modernizing Belmont Park by including this critical project in the state budget.

RE: Support for the Belmont Park Modernization Project

The proposed project to modernize Belmont Park on Long Island is a top economic development priority for New York State.

This project is expected to generate immense economic benefits, including **\$1 billion** in construction-related economic impact and **3,700 construction jobs**. In addition, it would create a recurring **\$155 million** in annual economic impact upon completion and sustain **740 new full time jobs**. These benefits would come at **no cost to taxpayers** and would help secure the future of horse racing in New York State, which **generates \$3 billion in annual economic activity and sustains 19,000 jobs for New Yorkers** — buoying the economy on Long Island, in the Capitol Region, and across the Empire State.
